

Protecting your private information is our priority. This Statement of Privacy applies to www.stepinshield.com and Step in LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Step in LLC include www.stepinshield.com and STEP-IN. The STEP-IN website is a ecommerce site. By using the STEP-IN website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, STEP-IN may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase STEP-IN's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through STEP-IN's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

STEP-IN does not sell, rent or lease its customer lists to third parties.

STEP-IN may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. STEP-IN may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to STEP-IN, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

STEP-IN may keep track of the websites and pages our users visit within STEP-IN, in order to determine what STEP-IN services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by STEP-IN. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the STEP-IN website.

Use of Cookies

The STEP-IN website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
